- Enjoy Instant Balance: When enabled, you can securely preview balances without logging in.
- Deposit Checks: Deposit paper checks using your phone's or tablet's built-in camera.
- Make External Transfers: Transfer money between your LFCU account and accounts from other financial institutions.
- Transfer Person to Person: In place of purchasing gift cards, send money to people with custom messages, such as "Happy Birthday," and add unique designs.
- Pay Your Bills: Schedule payments to companies.
- View Recent Transactions: View recent and pending transactions.
- View Check Images: View images of the fronts and backs of your checks.
- Transfer Funds: Easily move money between your LFCU accounts.
- Add Contacts: Add companies and people to whom you need to send money.
- Request Money: Request money from other people.

- Receive Money: Accept payments from other people.
- Account Balances: View your account balances in real-time.
- Apply for Loans: Complete online loan applications.

Dormant Accounts - After Three Years, It's Use It Or Lose It

LFCU is required by the State of Texas to close all dormant member accounts (those with no member-generated transactions within the last three years) and remit the funds to the State of Texas.

If you have a dormant account with LFCU, you should have recently received a notification by postal mail. We encourage you to restore your account to active status by making a withdrawal or deposit of as little as \$1. For details, contact the credit union at 972-766-6732.

If your personal information has changed in the last year, such as your personal email address and cell and home phone numbers, please provide the new details to LFCU. Note: updating your personal data in the company's system does not update the credit union's records.

By keeping your personal information up to date, LFCU can alert you of suspicious activity on your LFCU debit or credit cards, provide information regarding your account activity, etc.

Simply log in to your LFCU home banking profile, and click on the "User Profile" tab, "User Preferences" and the "Change Personal Information" box to make your changes. Your information will be kept confidential and only used to update the LFCU member database.
