To serve you in the best way possible, we encourage you to maintain accurate contact information with LFCU. If you've moved, changed your phone number or updated your email address, please provide the new details to the credit union. (Note: Updating your personal data in the company's system does not update the credit union's records.)

By keeping your personal information up to date, LFCU can alert you of suspicious activity on your LFCU debit or credit cards, provide information regarding your account activity, etc.

Simply log in to your LFCU home banking profile, and click on the "User Profile" tab, "User Preferences" and the "Change Personal Information" box to make your changes. Your information will be kept confidential and only used to update the LFCU member database.

Receive Account Statements Sooner

When you enroll in LFCU e-Notifications, 1099-INT notifications, eAlerts and eStatements, you will receive electronic alerts for various account activities. Also, you'll receive the information much faster than monthly and quarterly paper statements. This can help you can prepare your taxes more quickly.

To enjoy the convenience of e-Statements, LFCU online banking users can simply log in to online banking at lifetimefcu.org; click on the "Service" tab; select "Enrollment"; check "1099-INT Notifications", "eStatements" and "eNotifications"; and follow the prompts. You'll receive an email when your statements are ready for viewing.

Monthly Dividends LFCU's Board of Directors declares dividend rates on share accounts at the beginning of each month, which you may view online at lifetimefcu.org.
